EATON TOWNSHIP BOARD MEETING May 5, 2022

Supervisor Roberts opened the Kristen Way and Tina Lane Special Assessment hearing and the regular May meeting with the pledge to the flag of our Country.

Roll Call: Present at the Township Hall were Supervisor Roberts, Clerk Patterson, Trustee Droscha, Treasurer Dolman and Trustee Bankhead.

Absent: None

Supervisor Roberts opened the Public Hearing to review the Kristen Way & Tina Lane Special Assessment. He gave an explanation of the quote and the breakdown of the expenses.

Public Comments on the Kristen Way & Tina Lane Assessment:

A letter from Mr. Baum was provided to the board and read aloud by Trustee Droscha. He was also present at the meeting and commented about the road specs. He asked about the warranty on the road from American Asphalt and how long they anticipate the road to last. Commenting that after it's compacted you will end up with 3.5 not 4 inches.

Mr. Erhardt provided a letter to the board that was read aloud by Clerk Patterson.

Supervisor Roberts stated that it will need to be seal coated in 2 years which would expense of the residence.

Mrs. VanderMolen stated a road with normal travel lasts roughly 20 years. With the travel on Kristen Way & Tina Lane she thought theirs would last 30-40 years.

Trustee Bankhead asked if anyone present opposed the improvement. No one in the audience opposed.

Mr. VanderMolen stated that the roads were initially meant to be paved but it didn't happen.

Mr. Gilding spoke on having the company come back to fill potholes.

Treasurer Dolman went back over the numbers.

Mrs. Haruska asked if it will be on both summer & winter taxes. She also wanted to know if it could be paid off early. Treasurer Dolman gave an explanation.

Trustee Drosha asked if someone sells after the road has been paved if the buyer would be responsible. They would not be responsible. The seller would be responsible to pay the assessment off.

Mrs. Haruska asked what the next step would be. Supervisor Roberts stated that he would call American Asphalt tomorrow, Friday, to get it scheduled.

Mrs. VanderMolen asked if the township knew when Flanders was going to paved. Supervisor Roberts said he did not have a date.

Mr. Gilding brought up the streets in the Blair Acre subdivision. He stated that no one has been contracted for sealing roads in the county. Their subdivision hasn't had any maintenance and isn't slated to have anything done to it. He thought it was supposed to be scheduled for crack sealing.

Mrs. VanderMolen asked what a ballpark figure might be for sealing on the road. Supervisor Roberts didn't have one. Treasure Dolman said that their road is hard to estimate the cost on.

Supervisor Roberts closed the Public Hearing at 7:36pm and opened the regular May meeting of the Eaton Township Board. Supported by Trustee Droscha & was seconded from Trustee Bankhead.

REPORTS

<u>County Commissioner</u>: County Commissioner Droscha was present and reported that because of all of the rain some of the projects have been delayed. There was discussion regarding road patrol and staffing. This included recruitment and retention.

<u>Library:</u> Mrs. Borrelli was present and reported that construction is underway in the Spartan Room. The old chairs are being used at the old courthouse. The charging station is free for 2 hours but the user gets charged after that.

<u>Rural Fire:</u> Supervisor Roberts stated that RFA is still hoping to have a say in the budget. He anticipates there will be a meeting in the middle of May. There hasn't been a meeting date set.

<u>CECC</u>: Supervisor Roberts reported that a resident called concerned about a water leak so he went out there but found no evidence of a leak. Clerk Patterson reported that she is waiting to receive quotes back regarding the tree on the old side of the cemetery.

<u>Recreation Co-op</u>: Trustee Bankhead gave a brief report. There were kids on the diamond! The field can be scheduled on the city website. Trustee Droscha said the grass is growing nicely out there.

Assessing: There are a couple cases that might require a deposition.

<u>Airport</u>: Supervisor Roberts reported they had a meeting. They would like the trees cut. Some will be taken out completely and others will be trimmed. The building needs a new roof.

Clerk Patterson reported that the Special Election had a low turnout. She gave the results from Tuesday.
